INFORMATION ON THE RESULT OF THE PROCEDURE

Regarding: Science contract for the supply of elements of the vacuum system for the diagnostics of VUV radiation on the JT60-SA, case No: 78/STiO/2022

I. CHOOSING THE MOST ADVANTAGEOUS OFFER

The Ordering Party chose the offer No. 1 Part II as the most advantageous, submitted by the Contractor:

APVACUUM Sp. z o.o, ul. Klonowa 24, 62-002 Suchy Las

<u>Justification for the selection</u>: The offer has been correctly submitted, meets all the requirements of the Ordering Party specified in the Competition Notice and is not subject to rejection. Gross offer price of the above-mentioned Contractor is **PLN 67 035,00** and is included in the Awarding Entity's budget allocated to the contract. The offer obtained **100 points** in the adopted offer evaluation criteria.

- 2) Justification of the points awarded:
- a) APVACUUM Sp. z o.o, ul. Klonowa 24, 62-002 Suchy Las (oferta nr 1)

Price criterion - points have been calculated in accordance with the formula provided in Chapter XIV paragraph 2 of the Notice of Competition. The price of the Contractor's offer is PLN 67,035.00, the score is 100 points.

3) The Contracting Authority informs that it has rejected the offer of:

PREVAC Sp. z o.o., ul. Raciborska 61, 44-362 Rogów (oferta nr 2)

In the offer submitted by PREVAC Sp. z o.o. the price is given in euro, while in accordance with Chapter XII point 1 of the Notice of Competition, the price should be given in PLN.

In addition, Appendix 1 to the Offer (Technical Specification) in points: 3.1 for Part I, and in points for Part II: 1.1; 1.4; 2.1; 3.1; 1.2; 1.3 and 2.4 to the offer do not contain all the data, or the data do not meet the requirements.
